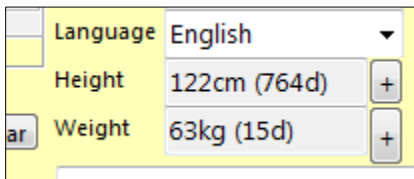
### Charting

#### [52533] Patient Charting screen enhancement

Feature: The Patient Charting screen now has a new interface. Kroll now has the ability to support 80 different lab values. The charting area can still be accessed by clicking **CTRL-T** from the patient card or click on the 'Charting' button from the ribbon bar or 'View' menu.



The legacy height and weight values from the patient card have now been converted into the new charting tables and the patient card will show the most recent entry including its age. In order to add a new reading, you can click on the '+' button beside each field.

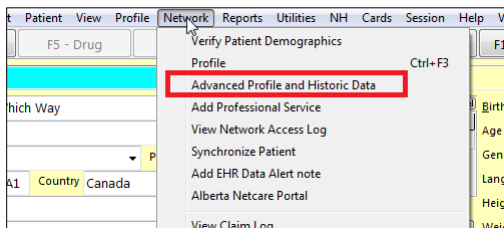
## User Interface

### [50727] Unlimited refills disabled for Newfoundland and Labrador

Feature: As requested by the Newfoundland Centre for Health Information, the unlimited refills option has been disabled for new Rx's. Existing Rx's that already have the unlimited refill option enabled will continue to be honored.

### [47329] 'Advanced profile' menu item has now been renamed (Alberta)

Feature: The 'Advanced Profile' menu item under the 'Network' drop-down has been renamed to 'Advanced Profile and Historic Data' and the 'Clinically Relevant Profile' option is now off thus returning a full historical profile by default.



### [46819] Filling Fee for Service no longer displays Netcare Profile (Alberta)

Feature: When filling a Fee for Service, the user is no longer prompted to view the Netcare Profile when the province is set to Alberta.

### [49802] Rx Card Updates (Nova Scotia)

Feature: The Rx Card has been changed to automatically update the 'Dispense Allowed' period and 'Administration' period start date when the written date is modified.

### [52166] Copy to new for generic drug substitution

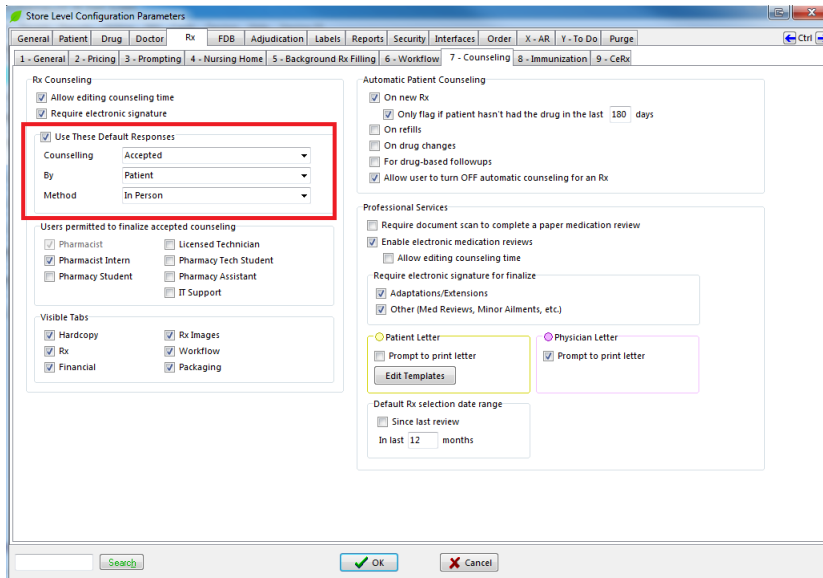
Feature: When copying to a new Rx and selecting a generically equivalent drug, the same prescription order identifier is set to Point Click Care thus preventing nurses from having to discontinue the old and acknowledge the new Rx.

### [49548] 2D Barcode now available on the Compliance Checklist

Feature: The 2D barcode has been added to the compliance Checklist. This barcode contains the information required to identify it as a 'Compliance Checklist' when scanning the document back in to Patient Profile. This will include documents scanned via both the typical document scanning utility, and through the Fax/Network scan method.

[35410] Users now have the ability to Skip the counseling wizard

Feature: Users are now able to skip the counseling wizard by selecting default answers. Under **File > Configuration > Store > Rx > 7- Counselling**, place a check beside 'Use These Default Responses' and set the responses to the desired defaults.



With this enabled, when performing an Rx Counseling, the default answers are already applied and you are immediately presented with the finalization screen. You need only override the default responses for the exceptional cases. Also note, that a new Rejected reason of 'Missed Opportunity' can now be specified to report on any situations where the pharmacist was unable to perform the counseling session.

[50454] Forced Searching in Client Registry increased to 30 days (Alberta)

Feature: Forced searching in client registry has been increased from 1 day to 30 days only for out of province patients with no PHN.

[46785] A warning message appears when there is an open cycle count

Feature: When there is an outstanding cycle count, a warning will appear across the bottom of the screen. You can click on the 'X' to dismiss this message or it will be dismissed once the cycle count has been closed.
